DELEGATION POLICY FOR GMC CONFERENCE 2024:

Dear sir/madam,

The Senior Secretariat would like to bring to your attention the Delegation Policy and the scoring criteria for delegations that will be implemented during for the GMC Conference 2024: 1st National Edition that is scheduled for the 8th, 9th and 10th of March, 2024.

It is presumed that the Head Delegate or the Delegation Leader of each group participating in the GMC Conference 2024 has reviewed, understood, and agreed to comply with the policies outlined below, in addition to the overarching Conference Policy of GECCS MUN Club. It is also expected that the Delegation Leader has communicated these regulations to every member of their delegation.

For the purposes of this document and its application as an enforceable policy, unless specified otherwise by the Senior Secretariat, the term "delegate" encompasses any individual who has completed the payment of the specified delegate fees and has been assigned to one of the 5 committees as detailed on the official GECCS MUN Club's website at www.gmcconference.com.

Delegate Fees per delegate:

1. Priority Rounds: INR 1,000/-
2. Regular Rounds: INR 1,200/-

Delegation Recognition:

1. Official communications from the conference's General Secretariat to the delegations will be conducted exclusively through a designated point of contact. This individual will be mutually acknowledged by both the conference organizers and the respective delegation as the Head Delegate or the Delegation Leader.
2. Delegations may be categorized as either institutional or non-institutional. Non-institutional delegations are required to adopt suitable names for identification purposes. Institutional delegations must comprise students from the same educational institution. It is important to note that students from different schools or colleges affiliated with the same university or educational trust are not permitted to form a single institutional delegation.
3. In instances where multiple delegations from the same educational institution seek to register as institutional delegations, priority will be given to the delegation that can present a letter of authorization from the institution's Dean or Principal. This letter must explicitly recognize the delegation led by the specified Head Delegate or Delegation Leader as the institution's official representative.

Scoring System:

1. The evaluation of delegations will adhere to the specified scoring criteria:

For all committees with the exception of the International Press Corps:

- Best Delegate: 5 points
- High Commendation: 3 points
- Special Mention: 2 points.

For the International Press Corps:

- Best Journalist: 5 points
- High Commendable Journalist: 2 points.
- Best Photographer: 5 points
- High Commendable Photographer: 2 points.

2. Each simulated committee at GMC Conference 2024 is required to present at most one Best Delegate award and one High Commendation award. Should there be multiple recipients of the Special Mention award, the points designated for this award will be distributed evenly among the recipients. For instance, if a committee awards Special Mention to two delegates, each will receive 1 point.
3. In cases where delegations accumulate equal total points, precedence will be given to the delegation with the greater number of Best Delegate awards to determine the winner. Should a tie still exist, the delegation with the highest combined total of Best Delegate and High Commendation awards will be deemed the winner. If a tie remains under these conditions, the award for Best Delegation will be conferred to the smaller delegation, in recognition of achieving a higher average score.
4. Decisions rendered by the Senior Secretariat of GMC Conference 2024 are conclusive and not open to any challenges.
5. The Senior Secretariat of GMC Conference 2024 disclaims all responsibility for any miscommunication or for the provision of incorrect or outdated information by the heads of their respective delegations. The Senior Secretariat retains the authority to modify the Delegation Policy, with all amendments to be communicated directly to the Delegation Heads.
